The news, as you will know, has been full of talk of schools re-opening and what that might mean for children in Primary and Secondary School. In this newsletter, I thought it would be helpful to provide you with information in relation to Waddesdon.

Firstly, all of our planning and preparation for the eventual re-opening of the school will be focused on supporting children, families, and our staff in the best way we can.

It will reflect our belief in the value of each individual in our care – students and staff - and their wider families. People have already faced differing pressures and strains during this time and we are mindful of the many factors which have affected children, families and staff, amongst which are issues relating to bereavement, anxiety, work pressures and strained relationships.

It is clear that we will not be returning to "normal" when we re-open. We will not have a normal summer term, nor will the start of the new year in September, be normal. However, whatever we do, will reflect and uphold the Waddesdon Way.

A crucial part of our preparation will be consultation with you, with staff and Governors. Our scenario planning and risk assessments will be based on existing scientific evidence and the guidelines published by the DfE and Buckinghamshire Council.

In the meantime, it is hard to believe that we are starting the last week of the May half term. I would like to take this opportunity to thank you for your continuing support. No work will be set on  $1^{st}$  June which is a calendared INSET Day. Teachers will devote the day to strategic planning and preparation for next year.

## School Re-opening

The Government has indicated that school re-opening will be determined by five tests which need to be met and sustained:

- Making sure the NHS can cope
- A 'sustained and consistent' fall in the daily death rate
- Rate of infection decreasing to 'manageable levels'
- Ensuring supply of tests and PPE can meet future demand
- Being confident any adjustments would not risk a second peak

Because there is no imminent instant resolution to COVID within the next 18 months (i.e. a mass vaccine), the phased expansion is likely to be gradual and dictated by the principles of effective protective measures to ensure infection control in schools. Considerations will need to be given to workforce availability, the practicalities of in-school social distancing, timings of the school day, staggered lunches and free time, transportation, cleaning and hygiene, as well as reassuring understandably nervous parents and staff.

#### **Year 10 and 12**

In the DfE guidance published on Monday, 11<sup>th</sup> May, secondary schools were asked to consider how they would offer some face-to-face support to supplement the remote education of Year 10 and Year 12 students who are due to take key exams next year, alongside the full time provision they are offering to priority groups.

On the 12<sup>th</sup> of May, the DfE clarified that they did not intend for Year 10 and Year 12 to begin attending normal classes; instead there appears to be a growing consensus that schools, if they are able, could organise something akin to an Academic Review Day where those teachers who are not shielding, and able to attend school, would gauge progress made since the lockdown and establish how to support each young person further. Our commitment firmly remains to enable our young people to achieve well in their GCSEs and A Levels.

### **Parental consultation**

We will consult with you fully during this process. This will take place in three phases: identifying concerns and questions; publishing a risk assessment; and finally ascertaining which students are able to return to school. In the first instance, it would be helpful if you would direct your **concerns and questions** to <a href="mailto:office@waddesdonschool.com">office@waddesdonschool.com</a>. I will collate a summary of them for the next newsletter as well as using them to inform the work that is already taking place on the school risk assessment.



In a few cases, there are persistent issues with Show My Homework. If you are in this situation, I can appreciate how frustrating this is for you, as you also juggle home learning with your other responsibilities. #### **Push Notifications**

Parents can choose to receive emails or push notifications for a range of features on SMHW. You can manage this in your 'Account Settings'.

## For example:

- Every time your child's homework is recorded as 'Not Submitted'.
- After school task reminder (daily at 3pm) "[Student name] has [number remaining] out of [number due] tasks still to be completed for tomorrow."
- Before school task reminder (daily at 7:30am) "[Student name] has [subject 1], [subject 2], [subject 3] and [x] other homeworks to hand in today".

Parents can also subscribe to a weekly digest email. You will receive an email on Friday with details of your child's homework due in next week. This is only sent if your child has homework due next week.

#### SENIOR CATEGORY


Born between 1 July 2001 and 30 June 2006 (14-18 years of age)

- Imagine you are President of one of the Commonwealth's 31 Small States and you have been invited to give a speech on climate change to other Commonwealth leaders, what will you say?
- There is no Planet B: How will climate change affect you and your community?
- "We will never stop fighting for this planet" - Greta Thunberg. How can young people make change happen?
- The destruction of the oceans is everyone's concern.

#### JUNIOR CATEGORY

Born on or after 1 July 2006 (under 14 years of age)

- Imagine you are Planet Earth, what would you say to humans?
- A Blue Commonwealth: it is not too late to save our oceans. True or false?
- In 2019, students in more than 100 countries walked out of school to protest climate change. How can young people get their voices heard and make a difference?
- My planet, my place.



#### STARTER ACTIVITIES

#### GIVE ME FIVE!

To help children plan stories and identify key plot points

- Start with a closed hand. Pick a story the child knows well and explain it to them in 5 key points, open one finger each time you start a new point.
- Help the child plan their story: What will happen? Who is in the story? How will it end?
- Ask them to share their own story outline using the same method you did. Each time they start a new point, raise a finger.
- Encourage them to use words like 'First..', 'Then..' and 'Finally...'to create a clear structure.

### SPARK A STORY


To encourage imagination and consider different perspectives

- Show the child before and after pictures of oceans/forests affected by climate change.
- Ask the child to imagine they live in those places. What changes would they wish to see? How could children help?
- Consider what future life might be like in that city and in your city – how will they both be affected by climate change?
- Write a story based on these observations. It could be from both perspectives, maybe as witnessed by a bird flying over both countries...

#### GUIDELINES

- Nationals and residents of all Commonwealth countries and territories aged 18 and under are eligible to enter the competition, including entrants from the Maldives and Zimbabwe.
- All entries must be written in English
- Entries are accepted from residents of non-Commonwealth countries who submit through their local RCS branch.
- Entrants can be presented in any form/ method of creative writing. Pictures/ Illustrations are particularly encouraged in the Junior Category.
